Terms and conditions

- 1. By signing this application form, you are committing to attend the Advanced Leadership Programme.
- 2. The full fee of €12500, or equivalent in sterling, is payable even if you are unable to attend all 5 modules. Timoney Leadership Institute is a not-for-profit educational charity and full payment of fees by all delegates is required in order for the programme to breakeven and cover its operational costs. The full fee can be treated as a normal business expense when calculating your company's or personal tax liability.
- 3. The venue for the 4 modules in Ireland is the K Club, Kildare Hotel, Straffan, Co Kildare. The May module will take place in the San Telmo International Institute in Seville, Spain.
- 4. The fee for the programme covers the following expenses:
 - a. All programme materials.
 - b. Accommodation on the night of the first day of each module. In the case of the May module in Seville, accommodation for 3 nights is included. Accommodation is for one person; an additional fee will be incurred if accompanied by a spouse.
 - c. Lunch and dinner on the first day of each module; breakfast and lunch on the second day of each module as well as refreshments in between.
 - d. Travel by coach to and from the hotel to the San Telmo campus in Seville, and to additional social events while in Seville.
- 5. To guarantee a place on this Advanced Leadership Programme, please return the application form by email or post before 1st October 2017 along with a deposit for €600.
- 6. Payment in full must be made by 31st December 2017. A phased payment schedule can be arranged if preferred but please contact the office to agree the details of this in advance.
- 7. Due to the nature of the arrangements with the hotel and with the speakers, a refund is not possible after 31st December 2017. If you are unable to attend in the given year, Timoney Leadership Institute will endeavor to accommodate you on the following year.
- 8. You are asked to cover any additional expenses arising in the hotel, such as use of the mini-bar in your bedroom, laundry services, porterage, taxi, telephone, etc.
